Subject: - **Online Registration of NEET UG-2023 qualified candidates of UT of J&K/Ladakh for admission to Ayush and BPT Courses-2023.**

Notification No. 076-BOPEE of 2023

Dated 02-09-2023

Consequent upon declaration of the NEET UG- 2023 result by the National Testing Agency (NTA) on 13-06-2023, and to update the category status vis a vis preparation of the Provisional UT Merit List of registered candidates for admission to BAMS/BUMS/BPT Courses-2023, it is hereby notified for the information of all the candidates who have secured the minimum qualifying marks in NEET UG -2023 and have not registered themselves earlier but are willing to participate in online counseling process for BAMS/BUMS/BPT Courses shall be required to register themselves afresh and upload the following documents with effect from **04-09-2023 to 07-09-2023**:-

- I. NEET –UG – 2023 Score Card
- II. 10+2 marks card.
- III. Domicile Certificate of UT of J&K (ST Category Certificate in respect of candidates belonging to the UT of Ladakh).
- IV. Category Certificate, wherever required.
- V. Date of Birth Certificate (Matriculation).

The cut-off score for different categories as notified by NTA is as under: -

(a) Open Merit (including EWS/ JKPM/Child of PMF/CDP/Sports)	= 137
(b) Open Merit (EWS/ Handicapped/PWD)	= 121
(c) SC/ST/RBA/ALC/IB/OSC/PSP (For J&K/ Ladakh)	= 107
(d) SC/ST/RBA/ALC/IB/OSC/PSP (Handicapped/PWD)	= 107
(e) ST (Physically Handicapped/PWD)	= 108

The tentative NEET Score list of candidates of J&K, who have appeared in the NEET UG 2023 has already been notified by the Board vide Notification No.035-BOPEE of 2023 dated 06.07.2023 and Notice No. 041-BOPEE of 2023 dated 15.07.2023, which are available on the BOPEE website viz. www.jkbopee.gov.in only.

The candidates who have already registered for NEET MBBS/BDS Courses-2023 and whose name(s) are already figuring in PML notified vide Notification No. 045-BOPEE of 2023 dated 27-07-2023 need not to register again for Ayush Courses - 2023.

The candidates who are already registered for NEET MBBS/BDS Courses - 2023 but have either failed to clear their deficient documents as per Notification No. 045-BOPEE of 2023 dated 27-07-2023 or whose forms are incomplete due to one reason or other are also eligible to participate in the counseling process for Ayush Courses - 2023 subject to the condition that they shall have to approach BOPEE office physically for clearing their deficiencies enabling them to participate in registration process within cutoff date fixed by the Board.

The e-Information Brochure for NEET-UG BAMS/BUMS/BPT-2023 Courses has already been uploaded on website of the Board. The candidates are advised to go through the e- Information Brochure before registration.

Note.

- i. No under process certificates shall be entertained.
- ii. There will be no Registration fee charged from the candidates.
- iii. Mobile phones should not be used for registration purposes for uploading of documents, as the software will not accept the same.
- iv. The category certificates issued only up to the last date of registration shall be entertained. Any certificate issued after the registration date shall not be entertained by the Board under any circumstances.
- v. The candidate must fulfill all the criteria as laid down in the NEET-UG 2023 Information Brochure of the NTA and Information Brochure of J&K BOPEE in respect of NEET-UG - 2023 Courses;
- vi. Any candidate found ineligible at any point of time shall not be allowed to participate in the counseling process notwithstanding the registration/NEET qualifying score fixed by the Ministry of Ayush; Government of India;
- vii. The candidates should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them; whenever required by the Board;
- viii. Candidates in their own interest, are advised not to share login password with other candidate/ person;
- ix. Board shall not be responsible for any mistake committed by the candidates, while making registration;

- x. After completion of the registration process, Board shall notify the provisional UT Merit List of all the candidates, which shall be used for Online or Offline counseling (as may be decided by the Board) by the candidates (filling up of the preferences) based on which allotment of seat shall be made;
- xi. Any candidate, who falls within the qualifying merit but fails to register himself/herself upto the cutoff date fixed by the board or does not upload the documents shall not be considered for allotment of any seat;
- xii. The competing candidates, in their own interest, are advised to go through the e-Information Brochure which is available on website of the Board viz. www.jkbopee.gov.in and go through the technical and other instructions before registering themselves;
- xiii. Since the admissions in the Professional Colleges is a time bound process, the candidates should not wait for last date of registration as it may be detrimental to the interest of the candidate(s);

The other Terms and Conditions shall remain the same as notified by the Board through e-Information Brochure, Notifications and Notices issued from time to time on the subject.

The candidates are advised to remain in touch with the BOPEE Website (www.jkbopee.gov.in) and should not wait for publication of Notices/Notifications in the Newspapers, which may get delayed for the reason beyond the control of the Board.
